






## **ISTD Programs**

## Canadian Survey of Cyber Security and Cybercrime

## This survey collects data

#### on:

- Implementation of cyber security practices
- Cost to prevent or detect cyber security incidents
- Volume and type of cyber security incidents
- Reporting of cyber security incidents
- Costs of recovering from cyber security incidents






- 13,000 enterprises data available for:

## Canadian Housing Statistics Program (CHSP)

- Statistics Canada is building a housing database which will link numerous administrative files (i.e., data files collected for the purpose of carrying out non-statistical programs – e.g., tax files, property assessment files, etc.)
  - Administrative files to be used either currently reside within Statistics Canada, or will be procured from external sources
- This linked database will address the issue of foreign ownership data, but will also be available for policy and program research and analysis.





### Canadian Housing Statistics Program (cont'd)

#### The CHSP will be a national housing database containing...

Identifiers	e.g. Property, Address, Owner
Addresses and geography	e.g. Full address of the property (Mailing, Legal, Civic), Geographic coordinates
Property Characteristics	e.g. Square footage, Structure Age, Lot size, Property type, Selling price, Latest assessed value, Market value
Owner Characteristics	e.g. Citizenship, Residency, Age, Sex, Marital Status, Income, Education, Household composition
Property Use	e.g. Use of the dwelling by the owner, Use of the property
Property Financing	e.g. Type of financing, Amortization period, Interest rate, Mortgage debt





## Canadian Housing Statistics Framework (cont'd)



Inclusion of every residential property in Canada, differentiated by:

- Property type and characteristics (e.g., single family, apartment, square footage, valuation, etc.)
- Type of owner (individuals, business, government, foreigners/non-residents)




Changes to the stock over time

- New builds
- Demolitions
- Destruction
- Transfers between type of owner



+ Valuation changes = New stock

## Canadian Housing Statistics Program (cont'd)

#### Next release: June 2018

- Resident/non-resident ownership with additional CMAs
  - BC: 3 additional CMAs; ON: 15 additional CMAs
  - All associated CSDs
  - Total provincial estimates
- Ownership characteristics for all Ontario and British Columbia CMAs (and associated CSDs)
  - Age, gender and income of resident owners
  - Type of owner
    - Household, Business, Other
